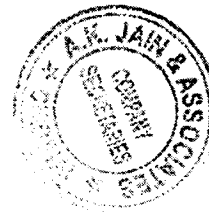
Sub: Scrutinizer Report on e-voting process conducted pursuant to the provisions of Section 108 and 110 of the Companies Act 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014

(1) The Board of Directors of **M/s. RANE ENGINE VALVE LIMITED** have on August 11, 2022 appointed M/s. A.K. Jain & Associates, Practicing Company Secretaries, represented by Mr. Balu Sridhar, Partner as a Scrutinizer for scrutinizing postal ballot which was conducted only through the electronic means pursuant to Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 and in terms of circulars issued by the Ministry of Corporate Affairs (MCA) vide its General Circular No. 03/2022 dated May 05, 2022 and read with its previous circulars (MCA Circulars) in this regard, for resolutions set out in the Postal Ballot Notice dated August 11, 2022.

In accordance with the aforementioned MCA Circulars and as confirmed by the Company, the Postal Ballot Notice dated August 11, 2022, in respect of the below mentioned resolution, was sent by email to all the Shareholders whose email addresses are registered with the Company/depositories.

(2) We hereby submit our report as under:

- (a) The company had completed on August 11, 2022, the dispatch of postal ballot notice to the members who have registered their e-mail addresses with the Company, their Registrars and Transfer Agents or Depository/Depository Participants whose name(s) appeared on the Register of Members / List of Beneficiaries as on August 05, 2022.
- (b) In compliance with MCA Circulars physical postal ballot forms were not dispatched by the Company. Accordingly, the receipt of Postal ballot forms does not arise.
- (c) The Company had published advertisement relating to the dispatch of postal ballot notice in Dinamani (Tamil) and Business Standard (English) newspapers on August 12, 2022.
- (d) The Notice of the Postal Ballot was made available on the website of the company www.ranegroup.com



- (e) The members of the Company as on the "cut-off" date i.e. Friday, August 05, 2022, were entitled to vote on the resolution mentioned in the postal ballot notice through remote e-voting platform provided by Central Depository Services (India) Limited (CDSL).
- (f) The e-voting commenced on Friday, August 12, 2022 at 9.00 A.M. (IST) and ended on Saturday, September 10, 2022 at 5.00 P.M. (IST)
- (g) The votes cast through remote e-voting were unblocked on Saturday, September 10, 2022 at 05.26 P.M. (IST) in the presence of (i) Mr. Rathish and (ii) Miss. Hemalatha who are not in the employment of the Company.
- (h) The votes cast through e-voting were scrutinized and the shareholdings were reconciled with the Register of Members of the Company / List of Beneficiaries as on August 05, 2022.


