Sub: Scrutinizer Report on e-voting process conducted pursuant to the provisions of Section 108 and 110 of the Companies Act 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014

(1) The Board of Directors of **M/s. RANE ENGINE VALVE LIMITED** have on October 31, 2023 appointed M/s. A.K. Jain & Associates, Practicing Company Secretaries, represented by Mr. Balu Sridhar, Partner as a Scrutinizer for scrutinizing postal ballot which was conducted only through the electronic means pursuant to Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 and in terms of circulars issued by the Ministry of Corporate Affairs (MCA) vide its General Circular No. 09/2023 dated September 25, 2023 read with its previous circulars (MCA Circulars) in this regard, for resolutions set out in the Postal Ballot Notice dated October 31, 2023.

- (b) In compliance with MCA Circulars physical postal ballot forms were not dispatched by the Company. Accordingly, the receipt of Postal ballot forms does not arise.
- (c) The Company had published advertisement relating to the dispatch of postal ballot notice in Hindu Tamizh Thisai (Tamil) and Business Standard (English) newspapers on November 08, 2023.
- (d) The Notice of the Postal Ballot was made available on the website of the company www.ranegroup.com

- (g) The votes cast through remote e-voting were unblocked on Thursday, December 07, 2023 at 17.15 P.M. (IST) in the presence of (i) Ms. Hemalatha (PAN: BFPPH7635F) and (ii) Mr. Mahesh Kumar (PAN: IAOPM6876A) who are not in the employment of the Company.
- (h) The votes cast through e-voting were scrutinized and the shareholdings were reconciled with the Register of Members of the Company / List of Beneficiaries as on Friday, October 27, 2023.


