### Summary of proceedings of NCLT Convened Meeting of Equity Shareholders

The Meeting of the equity shareholders of **Rane (Madras) Limited** convened by the Hon'ble National Company Law Tribunal, Chennai Bench ('NCLT') was held on **Wednesday, November 20, 2024** through video conferencing (VC) / Other Audio Visual Means (OAVM) at **16:00 hrs (IST)** ('meeting') for approving the Scheme of Amalgamation of Rane Engine Valve Limited, Rane Brake Lining Limited with and into Rane (Madras) Limited.

Mr. Siva Chandrasekaran, Authorized Person, welcomed the members of the meeting. He informed that all documents for inspection mentioned in notice convening the meeting are available for inspection along with the transcript of the proceedings of the meeting are being made available on the website of the Company. He introduced Mr. P S N Prasad, Chairman appointed by NCLT for the meeting and introduced Mr. Raymond, Advocate, who has been appointed as Scrutinizer for this meeting by the NCLT.
