*(3)(iii) "In addition to the above public notice, the Petitioner shall serve the notice of the Petition on the following Authorities namely, (a) Central Government through the office of the Regional Director (Southern Region), Ministry of Corporate Affairs (MCA), (b) Registrar of Companies, concerned, MCA, and (c) the jurisdictional Income Tax office having jurisdiction over the respective companies indicating specifically their Permanent Account Number (PAN) in the communication with copy of Chief Principal of Income Tax Office, (d) the office of the Official Liquidator for the First and*

*Second Petitioner Companies, and other sectoral regulators, if any, who may govern the working of the respective companies involved in the Scheme atleast 30 days before the date fixed for hearing of the above Petition."*

*(1) This Joint Company Petition filed by the Petitioner Companies viz. Rane Engine Valve Limited (CIN: L74999TN1972PLC006127) (for brevity "First Petitioner Company/ First Transferor Company"), Rane Brake Lining Limited (CIN: L63011TN2004PLC054948) (for brevity "Second Petitioner Company / Second Transferor Company") and Rane (Madras) Limited (CIN: L65993TN2004PLC052856) (for brevity "Third Petitioner Company/Transferee Company"), is coming up for admission and for fixing a date of hearing of the main Company Petition as well as for a direction in relation to publication in press to be effected and notices to be issued to the authorities concerned in relation to date of hearing of the Petition and calling for the objections, if any, to the Scheme of Amalgamation (hereinafter for brevity referred to as "SCHEME") contemplated between the Petitioner Company.*
