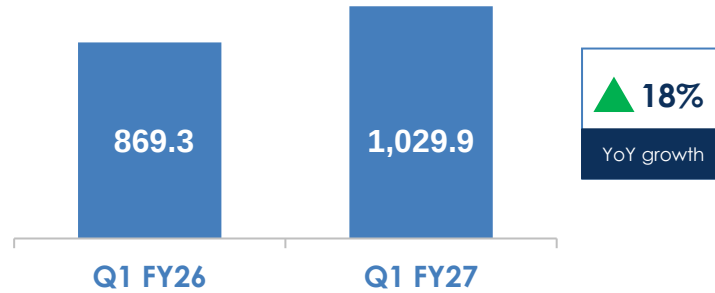

Net Sales (Rs cr.)

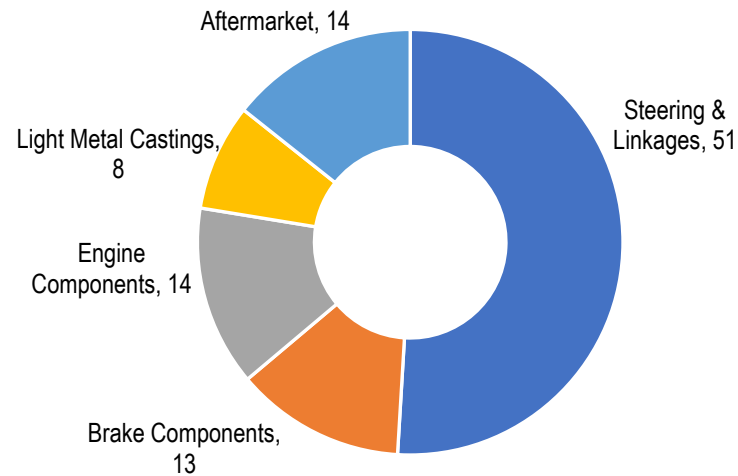


› **Net sales increased from Rs. 869.3 Cr in Q1 FY26 to Rs. 1,029.9 Cr in Q1 FY27**

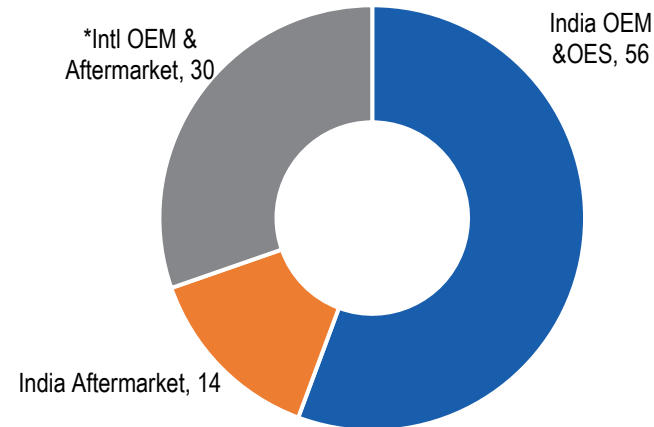
- Sales to Domestic OE customers grew by 13% mainly due to higher offtake in the passenger vehicle and farm tractor segment.

BY BUSINESS (%)

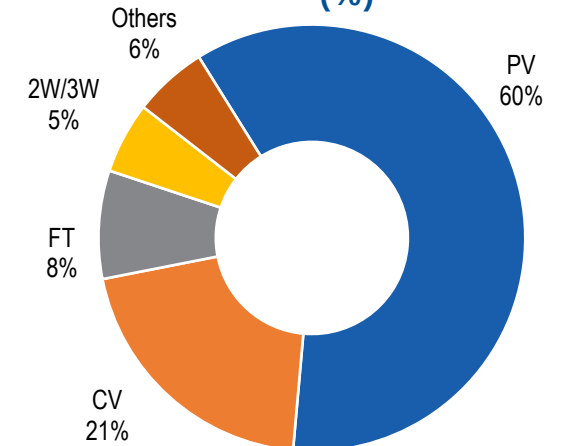

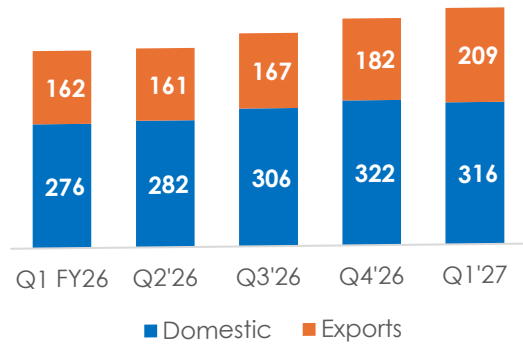
BY VEHICLE SEGMENT (%)

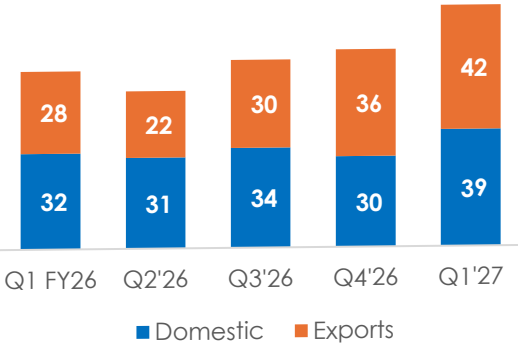

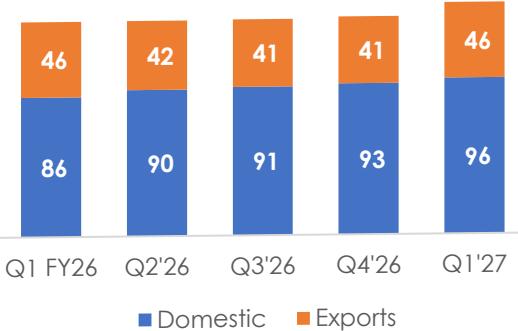

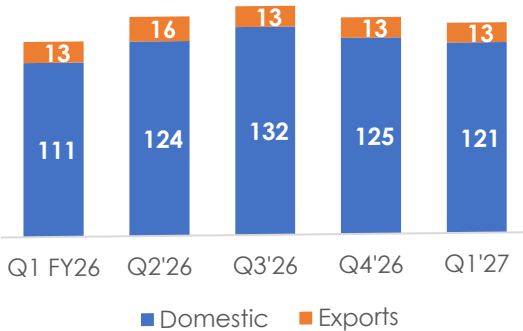

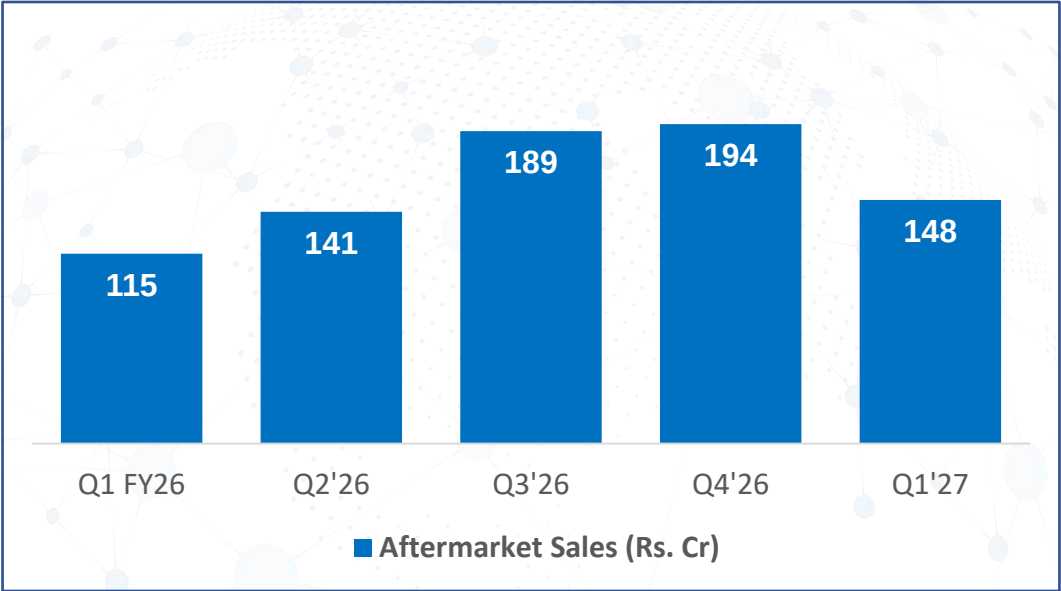

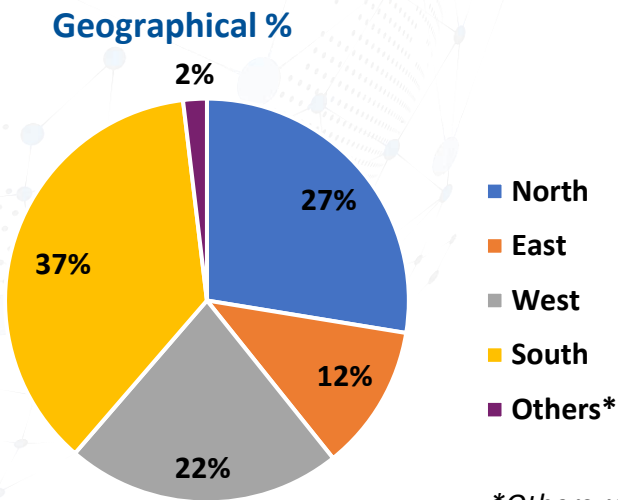
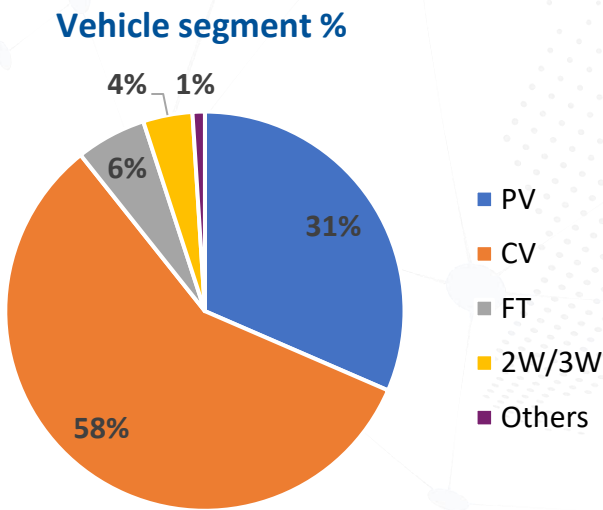
New Business Wins

- Order wins remained strong during Q1 FY27, with 24 new programs secured across multiple vehicle segments.
- These programs represent a Lifetime Value (LTV) of over Rs. 2,040 Crs. Export programs accounted for 54% of the total LTV, reflecting continued traction in international markets.
- The orders span both existing and new customer relationships, including EV applications, with an average program life of approximately six years, providing healthy long-term revenue visibility.
